525 SIGNAGE

1. Community Halls

The community signs have been installed. An amended invoice for the hall signs has been received. This invoice has being queried. A revised invoice is awaited.

2. Twinning Signs

A site visit with the County Council will be held on 21st January 2010 to assess the positioning of the signs.

3. Horeb Road

Priority signs. The Accident Research & Prevention Officer has provided the council's planning authority with an estimated cost to provide a 20mph speed limit on all the approaches to this junction, along with the new street lighting, traffic signage, markings and a raised junction plateau. Planning permission for a housing development in the vicinity has been sought. This development, if granted, would affect the volume of traffic in the area. The planning decision is still awaited.

526 GARAGES IN HOREB ROAD, MYNYDDYGARREG

Traffic congestion is still a problem in Horeb Road. The County Council is proceeding with a plan to demolish the garages and use the area for parking.

527 SPEED CONTROL VOLUNTEERS

Councillor J. Gilasbey had provided a report on the traffic monitoring operation that had been carried out jointly with PCSO Richi Wells. Members **RESOLVED** that the report should be presented to the County Council as evidence of traffic congestion and speeding in the town and in Mynyddygarreg.

528 REPAIRS TO PAVEMENTS AND POTHOLES

The following problems have been reported:-

The pavement near Passion for Flowers: the BT cover in the pavement near the Post Office. The County Council have been requested to install cycle racks at Glan yr Afon and also in the Town Square.

ENVIRONMENTAL ISSUES

529 DOG FOULING

Legislation which requires dogs to be on leads will not be enforceable until the end of the year. Signs need to be placed on land around Mynyddygarreg mountain. For legislation to be enforced, dog fouling must be reported to the Enforcement Officer of the County Council.

530 RECYCLING

On 23rd November 2009 Kidwelly and Mynyddygarreg was the first town in the county to have a complete door collection re-cycling service.

The County Council has been requested to provide glass banks in areas near Ger y Gwendraeth, Ger y Castell and Water Street.

531 PARKS STEERING GROUP

County Councillor K.Davies met with officers of the County Council on 9th December 2009. He reported that a detailed survey of the park would have to be made to determine the extent of the drainage problem and to make recommendations for solutions. The cost of the survey is not known, but it will be expensive.

The Chair thanked Burns Pet Nutrition for the use of their facilities as the lift at the Princess Gwenllian Centre was out of action due to freezing conditions. Councillor R.Thomas did not consider it appropriate to use private business premises for council meetings.

Matters Arising from the General Purposes Committee Meeting of 2nd November 2010

HIGHWAYS MATTERS

450 TRAFFIC CONTROL

Horeb Road

£35,000 has been allocated for traffic calming measures as part of the Section 106 payment in relation to the proposed new housing development in the area. Planning permission is awaited.

451 CAR PARK OFF STATION ROAD

The car park has been marked out ready for the line marking work to start. The car park has been swept with a mechanical sweeper.

452 PROPOSED YELLOW LINES

A request has been made for the lines outside the Rugby Club to be extended further along Station Road. A parking survey is being carried out to verify that a parking problem exists. Congestion at this location is a grave concern as emergency vehicles cannot negotiate around the obstructions caused by parked vehicles. The police will be informed of these concerns and requested to take action over illegally parked vehicles. The Town Clerk will request that the Fire service write a letter to the authorities outlining the problems of access and egress for their Fire Appliance. The Rugby Club will be requested to ask their players not to obstruct the street with their vehicles. It was noted that similar problems exist in Lady Street.

453 CYCLE LANES

Councillor Byron Huws had provided guidelines for the use of Cycle Lanes. The County Council has indicated its support of cycle lanes and a meeting with an officer of the council will be arranged.

ENVIRONMENTAL ISSUES

454 DOG FOULING

Burns Pet Nutrition will sponsor 2 bag dispensers which have been purchased. The locations for the dispensers have been forwarded to Burns so that the installation can proceed.

455 RECYCLING

The proposed recycling site near the former optical factory is unsuitable for a recycling centre. Further sites will be sought

456 PARKS STEERING GROUP

The date for the next meeting of the Parks Steering Group is awaited. An e-mail from the County Council outlining plans for the drainage works has been circulated.

MISCELLANEOUS ITEMS

457 CHRISTMAS LIGHTING ARRANGEMENTS

The Christmas Lighting ceremony took place on 25th November 2010. A review of this year's arrangements will be undertaken at the January meeting of the committee.

458 NOTICEBOARDS

It was agreed to investigate costs for noticeboards that would be in three sections to display news from Kidwelly, Mynyddygarreg and the Town Council. Quotes are awaited. It was noted that the use of noticeboards should comply with the "Marketing the Gap" strategy.

459 ANTI-SOCIAL BEHAVIOUR

Glan yr Afon – in the last PACT meeting it had been reported that feedback from the community had indicated that the problems have diminished. The Police are monitoring anti-social behaviour on the Town Square. It was reported that doorbells were being stolen and car ariels damaged. The police will be informed.

460 GARAGES AT HOREB ROAD

No further information has been received.

461 TREES AT PORTH Y CASTELL

Complaints have been received about the height of the trees which overhang the roadway at Porth y Castell. The ownership of this land cannot be determined. The County Council will be requested to cut back the trees.

462 20MPH SPEED LIMIT

Discussion about traffic calming measures took place. An integrated highways management plan would include roads, pavements and signage.
