536 LAND POLICY

Apologies:

1. Length of tenancies

Rationalising the length of tenancies was considered. How to best utilize the tender process to ensure good husbandry was achieved was discussed.

Several parcels of vacant land are landlocked, unable to be rented because of access issues. The possibility of linking tracts of land would alleviate this problem.

308 REVIEW OF THE MEDIA POLICY

It was agreed that the policy did reflect the present position:- The Town Clerk expresses the views of the Town Council. Individual councilors are free to express personal views. The policy will be reviewed with the intension of making it shorter.

309 REVIEW OF LAND AND LAND DISPOSAL POLICIES

A document had been circulated prior to the meeting of 9th October 2012 to be used as the focus for discussion. It covered the following areas:-

- 1. Re-tendering for existing tenants. Previous tenancies (good husbandry, improvement to land etc.) should be taken into account when the land goes for tender.
- 2. Termination agreements for existing tenants to give up the tenancy.
- 3. Arrangements for new tenancies
- 4. Factors affecting disposal of land.

The following points were made at the meeting on 9th October 2012:-

- 1. Historically, the town council has not invested in its land. Rental income has been used for special projects or has been absorbed into the revenue budget. The income has not been ploughed back into land maintenance.
- 2. Much of the land is in a poor state. Tenants should be actively encouraged to engage in good husbandry practice. Longer leases would encourage tenants to invest in the land.
- 3. Reminder letters at intervals would remind tenants of their responsibilities
- 4. Terms of tenancy agreements should be enforced to ensure the land is maintained effectively.
- 5. Disposal of land should not be entered into unless there are special circumstances prevailing.
- 6. Land management policies of other councils will be investigated

Enquiries had been made from other local community councils regarding their land management policies. However, no information was forthcoming as very few have land holdings. It was **RESOLVED** to explore the possibility of using a Land Agent to manage the estate and to contact local farmers for advice on land management issues.

The next Policy & Strategy Committee meeting scheduled for January 2013 will deal with the review of Standing Orders and Financial Regulations as required by the auditors. Any feedback received from Land Agents or farmers will be reported at this meeting.
